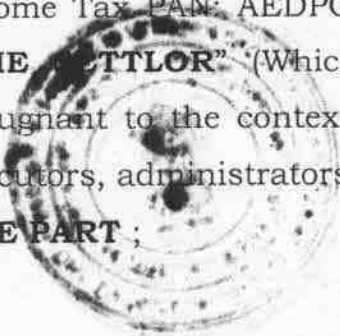

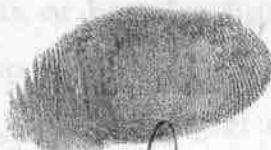

Hereinafter collectively called and referred to as "**THE TRUSTEES**" (Which expression shall unless excluded by or repugnant to the context be deemed to include them and the Trustees for the time being of these presents or the their survivors or successors in office and assigns) of the **OTHER PART**:

WHEREAS Major Pradeep Singh Gurung, Retd, the settlor is desirous of settling out of his separate funds of ` **11000/-** (Rupees Eleven Thousand only) of which he is the absolute owner, upon the Trust for public charitable purposes hereinafter mentioned **AND WHEREAS** the settlor has handed over and delivered the said sum of ` 11000/- (Rupees Eleven Thousand only) in cash to the Trustees to hold the said amount and/or the income therefrom upon trust for carrying out the objects of the Trust and on the terms and the conditions hereinafter declared concerning the same **AND WHEREAS** the Trustees have at the request of the Settlor agreed to act as the Trustees of these presents and to hold the said sum of ` 11000/- (Rupees Eleven Thousand only) and all other sums or properties that may from time to time form part of the Trust Estate upon the Trusts hereinafter declared or and concerning the same.

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:-

In this Trust deed, the following expressions shall where the context as permits have the following meanings respectively:-

- (i) The Trustees mean the Original Trustees or the Trustees in Office.
- (ii) The Trust Fund mean the abovementioned initial contribution in cash by the settlor and/or in kind, gift(s), all property(s) at any time added thereto by

way of further settlement, accumulation of income, capital accretion or otherwise and all properties of whatsoever nature whether immovable and movable from time to time.

The Trustee hereby declare that for effectuating the desire of settlor and in consideration of the promises the Settlor do hereby transfer, assign and make over to the Trustees the sum of ` 11000/- (Rupees Eleven Thousand only) in cash to hold the same and all other sums and properties that may from time to time form part of the Trust Estate unto the Trustees absolutely and for ever upon Trust for public charitable purposes, with and subject to the powers, provisions and declarations hereinafter contained of and concerning the same.

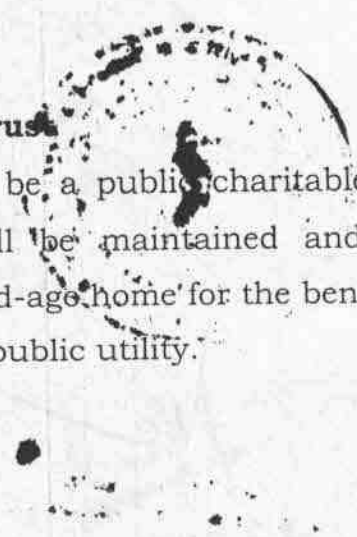
The name of the Trust shall be **"ENDEAVOUR GLOBAL TRUST"**.

Office of the Trust

The office of the Trust shall be situated at "Endeavour", Tea Auction Road, Mallaguri, Siliguri-734003 or at such other places as the Trustees may decide from time to time and determine. The area of operation of the Trust will be within the territorial jurisdiction of India.

Nature of the Trust

The Trust shall be a public charitable trust having no commercial or profit motives. It shall be maintained and administered to promote education, medical relief, old-age home for the benefit of weaker sections of public and any other objects of public utility.

Object of the Trust

The object of the Trust shall be public and charitable purposes and its income shall be applied, accumulated in India for public and charitable purposes not inconsistent with any of the provisions of the Income-tax Act, 1961 and any other statutory modification and without prejudice to the generality of the aforesaid as stated above, the following shall be deemed to be principal objects:-

(a) To establish, support, maintain and grant aid and other financial assistance to Schools, Colleges, Libraries, Reading Rooms, Lecture Halls, Research Laboratories and other Institution for research and development of Agricultural and Cottage Industries or any other scientific Research Institutes for the development of the knowledge of the human being.

(b) To establish Hostels, Boarding Houses, Residential Schools and/or Colleges, and other Research Institutes for providing accommodation to the students, professors and research scholars.

(c) To spread school and college level education to all parts of the society with special concern for girls and women, minority groups, differently abled persons and other less privileged groups.

(d) To grant scholarships, stipends, prizes, medals and other type of assistance including supply of books to the needy and deserving students, scholars and professors for studies, research and other activities relating to the development of scientific and technical knowledge of the human being.

(e) To open and impart such courses, diplomas, degrees for the development of the human faculties through knowledge in every sphere of life.

(f) To establish, maintain and grant aid or other financial assistance to Hospitals, Nursing Homes, Maternity Homes, Clinic, Charitable Dispensaries, Sanatorium and other establishments for giving medical relief to the poor, sick

and infirm persons and to render medical relief and financial assistance to the poor, sick and infirm persons.

(g) To grant relief during natural calamities, such as earthquake, flood, fire, pestilence and other occasions of calamities of similar nature and to give donations, subscriptions or contributions to the institutions, establishments or persons doing such relief work.

(h) To establish and/or to promote the establishment of rest houses and such other Institutions for the temporary residence and benefit of the needy public at places where such institutions may be necessary and useful.

(i) To grant aid for the establishment and maintenance of Tubewells, wells and water works and for the constructions of or repairs of wells for the use of the public in general.

(j) To grant aid to the poor persons.

(k) To help helpless widows and to establish, contribute or grant aid to institutions or funds for the benefit of women and children without any distinction of caste, creed or sex.

(l) To grant aid to child welfare centers, orphanages and widows's homes.

(m) To help in the improvement of the breed of cows and other animals useful to mankind and to take all steps for the increase of cheep milk supply for the improvement of health of the public in general.

(n) And generally any public and charitable purposes for public benefit without distinction of caste, creed, sex or nationality.

IN BEING EXPRESSLY DECLARED THAT if any one or more of the objects specified in this clause are held not being objects of public charitable nature as defined by the Income Tax Act, 1961 or any statutory modifications thereof, the Trustees are not to carry out such objects and the validity of the Trust so created by these presents as Trust for public and Charitable purposes shall not in any way be effected.

The First Trustee Shall be :-

- (i) Major Pradeep Singh Gurung, Retd
- (ii) Mrs. Renuka Gurung

The aforesaid Trustees have signed this deed also in acceptance of the office assigned to them.

Management of the Trust

The trust shall be administered by a board of trustees whose number shall not be less than 2(Two) or more than 7(Seven). The Board of trustee shall be formed by the permanent trustees for life and other nominated trustees. The permanent trustees will nominate other trustees as per their mutual consent and they will be called "Nominated Trustees". However the total number of permanent trustees and nominated trustees shall not exceed 7(Seven).

Terms of the office of the Permanent Trustee

- i) The above named First Trustees shall be trustees for life (hereinafter called permanent trustees).
- ii) The First Trustees can appoint any other two persons as Trustees for life (Permanent Trustees).
- ii) A permanent Trustee however may resign or retire as per his own decision and will.

iii) The Trustees for life (Permanent Trustees) can also appoint any other person as life Trustee in his/her place during the tenure of his/her life. In case of death of any Trustee for life, the remaining Trustees for life shall appoint a person as a Trustee in place of the deceased as per the will of the deceased or in case no will is being produced the appointment shall be from among the legal heir of deceased Trustee. Permanent Trustees shall not be less than two and more than four.

iv) In case all the Permanent Trustees are deceased together then the Remaining Board of Trustees shall appoint a maximum of four Life Trustees as per the will of the deceased and if no will has been left behind then from among the deceased's legal heirs.

Terms of the office of the Nominated Trustee

The term of office in case of nominated trustee shall be 3 years. Thereafter, they will be eligible for re-appointment at the discretion of the Permanent Trustees.

Vacancies

A Nominated Trustee shall cease to be in office with immediate effect on his becoming insolvent or insane or of on being convicted for any offences involving moral turpitude or at resignation. Any vacancy occurring in the office of trustees including those caused by retirement shall be filled by the permanent trustees, either unanimously or with the consent of the majority. The existence of vacancies in the office of trustees shall not invalidate any act or decisions by the board of trustees.

Administration of the Trust

i) Major Pradeep Singh Gurung Retd shall be the managing Trustee during his life time, but he may resign by giving notice in writing to his co-trustees if he so

desire. The managing Trustee shall be the Chairman of the meetings of the Trustee and shall have a casting vote.

ii) Any question arising in the administration of the Trust shall be decided by a vote of the majority of the Trustees as are present and voting at a duly convened meeting. The Chairman may also take administrative decisions which have to be ratified in the subsequent meeting. A resolution may also be passed by circulation. The Trustees will be Honorary and are not entitled to any remuneration. However, they would be entitled to travelling and such other expenses as the Board may deem fit and reasonable.

iii) The permanent trustees may from time to time delegate to any one of the trustees among themselves or to any other person, such of their powers and duties, as they deem fit, subject to, nevertheless to, their retaining the ultimate control and supervision.

Power of Trustees

The Trustees shall have following powers: -

(a) To manage the Trust properties for the time being and to do all the acts necessary for the preservation, maintenance and management of the Trust and/or the Trust properties and to apply the income of the Trust Estate for the objects of the Trust but if the majority of the Trustees so decide, the corpus of the Trust Funds may be similarly applied.

(b) To accept donations, contributions, grants, subscriptions etc. in cash or in kind from any person, company, firm, association of persons, H.U.F. or Family Trust or any body for the charitable objects of the Trust.

(c) To invest the income of the Trust properties not immediately required for the objects and the purposes of the Trust not in-consistent with the Income-Tax Act, 1961 or any other statutory modifications thereof.

(d) To vary from time to time, the investments representing the Trust properties or any part thereof or the income of the same, as the Trustees may think fit and proper with full power and liberty to sell or otherwise deal with the corpus of the Trust properties, not in-consistent with the Income Tax Act, 1961 or any other statutory modifications thereof.

(e) To give on rent, lease or on hire or demise any immovable or movable property of the Trust for such period or periods on such terms and conditions as the Trustees may think fit and proper, not in-consistent with the Income Tax Act, 1961 or any other statutory modifications thereof.

(f) To invest Trust fund or properties, whether representing the corpus or income in such investment, as the Trustees shall think fit and proper and keep invested the same either in the purchase of movable or immovable properties or granting loans to any person, firm, company or association or/of persons or granting loan on the securities of movable or immovable properties and to invest in the shares, stock or debentures of any company, not inconsistent with the provisions as provided in the Income Tax Act, 1961, or any other law for the time being in force.

(g) To convert and deal with the Trust property and/or vary from time to time the investments for the time being, not inconsistent with the Income-Tax Act, 1961 or any other statutory modifications thereof.

(h) To invest and keep invested the Trust fund either in purchase or mortgage of immovable properties or in shares, debentures or other securities and investment whether authorized by the Indian Trust Act, 1882 or not and to alter, vary or transfer such investments from time to time as the Trustees shall in their discretion think fit, not inconsistent with the Income-Tax Act, 1961 or any other statutory modifications thereof.

- (i) To borrow or raise or secure payment of money and also to lend money with or without security not inconsistent with the Income-Tax Act, 1961 or any other statutory modifications thereof.
- (j) To sell, dispose off, alienate or otherwise deal with any property movable or immovable comprising the trust fund not inconsistent with the Income-Tax Act, 1961 or any other statutory modifications thereof.
- (k) To let out, demise any immovable property comprise in the trust fund for such period and at such rent, on such terms and conditions as the trustees in their absolute discretion shall think fit, not inconsistent with the Income-Tax Act, 1961 or any other statutory modifications thereof.
- (l) To open account or accounts whether fixed, current or savings in the name of the Trust with any Bank or Banks and to operate the same jointly or severally or authorize any trustee or employee of the Trust to operate the same as the Board of Trustees shall decide from time to time.
- (m) To defend legal proceedings, to compromise or compound all actions, suits and legal proceedings and all differences and disputes touching the Trust estate and/or Trust Properties and to refer any such differences or disputes to Arbitration and to adjust and settle the accounts relating to the Trust Estate and/or the Trust Properties and to do all other things and acts things for the protection of the Trust properties as fully and effectually as if they were absolutely entitled to the Trust Estate and/or Trust Properties without being liable or answerable for any occasioned thereby.
- (n) To accept donation, subscriptions or assignment of properties whether in cash or in kind, from the settlor or any of his relatives or member or general public or from any Trust, charitable institution, firm or body of persons, body corporate and/or incorporated for the promotion of the objects herein before mentioned, provided that such contributions are given without any condition repugnant with the provisions herein contained.

(o) To amalgamate this Trust and its properties with any other Trust or charitable institutions having objects and purpose wholly similar to that of this Trust.

(p) To appoint a co-trustee or any other person as constituted attorney or agent or manager for any of the powers vested in them under these presents and from time to time remove such attorney or agents or managers and to appoint other or others in his/her or their place.

(q) To make, vary, alter or modify scheme, rules and regulations for carrying out the objects of the Trust and for the management of the affairs thereof and for the running of any institutions in the furtherance of the objects of the Trust and otherwise for giving effect to the objects of the Trust.

(r) In the event of any properties belonging to the Trust being acquired or requisitioned, to get the compensation and statutory allowance payable for such acquisition or requisition duly fixed and to receive, collect and realize all such compensation or statutory allowance and/or all other money as and when payable.

(s) To apply for and obtain bonus and right shares and/or other privileges and rights which may accrue or arise or may become payable on account or in respect of the shares, securities and investments for the time being.

(t) To make all legal actions that may be required in the course of the management of the Trust and to delegate such powers and authorities from time to time as may be necessary to any person for the purpose.

(u) The Trustees may make over and transfer the management of any institution or institutions established, run or maintained by the Trust to any committee or sub-committee consisting of such person or persons whether members of their body or not as they think fit and appoint such committee or

sub-committee for the management of the said Institutions and delegate any of their powers to such committee or sub-committee and may frame rules relating thereto from time to time as they shall from time to time think fit..

(v) Every Trustee may reimburse himself or pay or discharge out of Trust property, all expenses properly incurred in or about the execution of the Trust or for the realization, preservation or benefit of the Trust property. If he pays such expenses out of his own pocket he has first charge on the Trust property for such expenses and interest thereon, but such charge shall be enforced only by prohibiting any disposition of the property without previous payment of such expenses and interest.

(w) The Trustees shall be chargeable only for such moneys, stocks, shares and funds as shall actually come in to their hands and shall not be answerable and accountable for neglect, default, acts of commission or omission of the other Trustees nor of any Banker or other person with whom the Trust properties or any securities may have been deposited or handed over, unless caused by their willful neglect or default.

(x) The Trustees shall cause true and accurate accounts to be kept of all moneys received and spent and of all matters in respect thereof in course of management of the Trust properties or in relation to the carrying out of the object and purposes of the Trust as well as of all the assets, credits and effects of the Trust properties and shall adjust the same every year in a business like way.

(y) The Trustees will not be entitled to receive any remuneration but the Trustees may reimburse themselves of all expenses actually incurred by them in connection with the Trust or performing their duties relating thereto.

Other Rules & Regulations

A] A person shall cease to be a Trustee in any of the following events:

- (i) If he dies, or
- (ii) If he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year, whichever is longer, or
- (iii) If he becomes bankrupt, or
- (iv) If he becomes innocence or otherwise becomes incapable to act, and
- (v) If he resigns his office.

B] Subject to the general control and supervision of the Trustees, the Managing Trustee shall manage the Trust fund and carry on all the affairs of the Trust and shall have all the necessary powers and authorities for the purpose. The Managing Trustee shall call a meeting of the Board twice a year atleast.

C] Three Trustees shall form a quorum for any meeting of the Trustees. A meeting of the Trustees at which a quorum is present shall be entitled to exercise all or any of the powers vested in the Trustees under these presents or in law.

D] All questions arising at the meeting of the Trustees shall be decided by the majority of votes and in case of equality of votes the chairman shall have a second or casting vote.

E] No question dealing with the disposal of the corpus of any of the Trust properties will be decided and disposed of except with the consent of a majority of two-third of all the Trustees for the time being.

F] No person being :

- (i) an undischarged insolvent, or

(iii) of unsound mind, or

(iv) a minor

Shall be appointed a Trustee.

G] That every new Trustee appointed shall have the same powers, authorities and discretions and shall in all respects act as if he had been originally nominated as Trustee by the Settlor.

H] A resolution in writing circulated amongst all the Trustees and signed and agreed to by a majority of the Trustees shall be as valid and effectual as if it has been passed at a meeting of the Trustees duly called and convened.

I] Notices of the meeting of the Trustees and all communications may be sent to the Trustees at their respective addresses registered for the time being in the records of the Trust.

J] All meeting of the Trustees shall be held at such place or places as the Trustees may from time to time decide.

K] A Trustee who is unable to be present at a meeting of the Trustees may send his views on the Agenda in writing and such expression of opinion shall be taken to be his vote on the matters concerned.

L] The Minute of the proceedings of the every meeting of the Trustees shall be entered in the book to be kept for that purpose and signed by the chairman of such meeting or of the following meeting when they are read over and when so entered and signed by the chairman, then it is to be conclusive evidence of the business and other matters transacted at such meeting.

M] All acts and things in relation to the Trust fund may be done under the signature of the Managing Trustee or any Trustee or Trustees as the Trustees decide from time to time.

N] The Trustees may by resolution authorized in writing by majority, any one or more of them to execute any deed, document or instrument and so executed deed, document or instrument shall be deemed to have been executed by all the Trustees.

O] On a new Trustee being appointed and on his agreeing in writing to act as such, the Trust property shall vest on him along with other Trustees for the time being and he will be entitled to carry out all the duties and functions of the Trustees.

P] With the consent of all the Trustees for the time being of the Trust, the trustees shall be entitled to add to the objects of the Trust subject to the condition that any such addition shall be confined solely to charitable purpose within the meaning of Income-Tax Act, 1961 or any statutory modification thereof and by a majority of two-third of all the Trustees for the time being the Trustees will be entitled from time to time to add or alter rules and regulations herein mentioned.

Q] The Trustees may decide matters by circulation or at meetings as may be convenient to them. For the purpose of the meetings any three Trustees should be present and that will form the quorum. In the event of differences of opinion amongst the Trustees either at the meeting or in other case the opinion of the Managing Trustees shall prevail. If the votes are equal the decision of the managing Trustees, who shall be chairman of all the meetings or his nominee trustee shall prevail.

R] The yearly account of the Trust shall be made upto the 31st day of March of each year and if the Trustees so decide by resolution, the account may be

S] The managing Trustee may at any time make such arrangements, drawn up such a scheme or schemes and make and frame such bye-laws and rules as he shall in his discretion thinks fit for the administration of the Trust hereby constituted and the management of the property hereby conveyed or any part thereof or any other property for the time being subject to the provisions of this deed or any part thereof any may at any time amend, alter or repeal any of the said arrangements, schemes, bye- laws or rules as he shall think fit, provided that they are not in contravention to any provision of the Income Tax Act, 1961 and entitled to income tax relief or exemption under the said Act or other act in force for the time being.

W] At present the Trust has no assets either movable or immovable properties except the above said Trust fund of ` 11,000/- (Rupees Eleven Thousand Only).

X] It is expressly declared that the Trust is irrevocable and a Public Charitable Trust and all the provisions of this deed shall be construed accordingly.


